If any female sheep, which was described in the catalogue or at the time of sale as being in lamb, proves not to have been in lamb at the time of sale within 21 days after the day of sale the purchaser gives written notice to the auctioneers of his intention to return the animal, supported by a veterinary surgeon's certificate that such sheep has proved not to have been in lamb, then the purchaser may return such sheep to the vendor.
- All sheep will be sold in guineas and a commission of 5.25% will be charged by the Auctioneers on all sales.
- 4. An upset price of 150 guineas will stand on all sheep.
