- i) If any ram is proved incapable or ineffective at natural service and is to be returned by the purchaser to the vendor, it must be returned in reasonable condition not later than 5<sup>th</sup> December. The Purchaser agrees that the right to reject the ram and return it under this clause will be lost if the purchaser has after purchase taken semen from the ram. No claim on the vendor is to exceed the purchase price of the sheep.
- ii) Any female should be guaranteed free of lamb at time of sale unless otherwise stated. Any female animal should be returned by 5<sup>th</sup> January in reasonable condition. No claim should exceed the purchase price of the animal.
